REPORT SUMMARY: This item was placed on the Agenda at the request of Chairperson Henry C. Gonzalez. At the Special Meeting of December 9, 2014, the Board created an Ad Hoc Committee consisting of Chairperson Gonzalez, Board Member W.H. (Bill) De Witt, and Executive Director Michael Flad.

The committee met on January 7, 2015 to discuss upcoming negotiations with Time Warner NY Cable, LLC ("TWC"). At this time, the committee is working to schedule a meeting with TWC for the week of January 26, 2015.

At the Special Meeting of January 13, 2015, the Board removed from the Agenda three items: proposed Amendment No. 1 to Contract 1874 with TWC, considered imposing a 1% fee to continue funding the Public Access Channel, and provided direction on how to use available PAC funds.

Upon conclusion of discussions with TWC, the Ad Hoc Committee will bring recommendations for these three items to the Board at a later meeting date.
