I. Call to Order/Roll Call

CALL TO ORDER: W. H. (Bill) De Witt, Mayor called a Special City Council meeting to order at 5:30 p.m.

The Council Members recessed into Closed Session at 5:31 p.m. and reconvened at 6:32 p.m. with all Members of Council present. City Attorney Salinas reported the following:

1. CONFERENCE WITH LEGAL COUNSEL - PENDING LITIGATION

Pursuant to Government Code Section 54956.9(a), 54954.9(b)(3)(c)

- a. Georgina Becerra v. City of South Gate, et al.
- b. Daniel Dirige v. City of South Gate

Item 1(a) is a traffic accident related matter against the City of South Gate. The City Council on a motion made by Council Member Hurtado and seconded by Mayor De Witt and on a vote of 5-0, authorized the City Attorney's Office to defend the matter.

Item 1(b) is a claim that has not yet been materialized into a lawsuit involving a City vehicle that was involved in a traffic collision. The City Council on a motion made by Mayor De Witt seconded by Vice Mayor Davila and on a vote of 5-0, authorized the denial of that claim at this time.
