**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOUTH GATE
ACCEPTING GRANT FUNDS FROM THE STATE OF CALIFORNIA
DEPARTMENT OF ALCOHOLIC BEVERAGE CONTROL FOR THE
GRANT ASSISTANCE PROGRAM FOR FISCAL YEAR 2012-2013**

WHEREAS, the South Gate City Council desires to undertake the Grant Assistance Program (“GAP”) administered by the State of California Department of Alcoholic Beverage Control (“ABC”) in the amount of \$40,000 for the project term from July 1, 2012 through June 30, 2013; and

WHEREAS, in the past two years, Police Officers have worked in partnership with ABC investigators to meet various GAP objectives, including sting operations, Informed Merchants Preventing Alcohol-Related Crime Tendencies Inspections (IMPACT), and prevention and education programs that educate licensees how they can be part of the solution to reduce alcohol related crimes; and

WHEREAS, the grant award to the City is \$40,000 which is to be used to pay sworn Police Officers’ overtime expenses, equipment, operating expenses and education for Police Officers to deploy enforcement activity within the City for Fiscal Year 2012-2013;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SOUTH GATE DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The City Council hereby authorizes the Chief of Police of the City of South Gate to execute on behalf of the City Council the attached contract, including any extensions or amendments thereof.

SECTION 2. The City Council hereby authorizes the Chief of Police, on its behalf, to submit the attached Project Narrative proposal to ABC.



The City Council hereby agrees that any liability arising out of the performance of this contract, including civil court actions for damages, shall be the responsibility of the grant recipient and the authorizing agency, and that the State of California and ABC disclaim responsibility for any such liability.

SECTION 4. The City Council hereby acknowledges that the grant funds received hereunder shall not be used to supplement expenditures controlled by this body and that this award is not subject to local hiring freezes.

SECTION 5. The City Clerk shall certify to the adoption of the Resolution which shall be effective upon its adoption.




