**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOUTH GATE, CALIFORNIA, RECEIVING AND APPROVING THE PROGRAM YEAR 2014-2015 ACTION PLAN AND AUTHORIZING THE EXECUTION OF ALL NECESSARY DOCUMENTS FOR THE SUBMITTAL OF SAID PLAN TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT**

**WHEREAS**, the City of South Gate previously prepared and submitted the Five Year Consolidated Plan, which contained an Action Plan, to the U.S. Department of Housing and Urban Development ("HUD") on May 15, 2010; and

**WHEREAS**, the City is required to submit an Action Plan, such that it is due to HUD by August 16, 2014; and

**WHEREAS**, the Action Plan Update constitutes an application to HUD for Program Year 2014-15 federal funds from the Community Development Block Grant (CDBG), HOME Investment Partnership Grant (HOME), and the Emergency Solutions Grant (ESG); and

**WHEREAS**, the City Council did duly notice a public hearing for May 27, 2014, to hear public comment on the Action Plan; and

**WHEREAS**, the City has prepared a Consolidated Annual Action Plan Update with the participation of the South Gate Advisory Committee (CAC) and made it available for public consideration on March 26, 2009 at the City Clerk's Office and Community Development Department in City Hall; at the Chamber of Commerce Office and at the two County Public Libraries for the required thirty-day public review period; and

**WHEREAS**, the City published a Notice of Availability of the Action Plan and a Notice of Public Hearing on April 24, 2014 with the CAC's recommended allocations in the The South Gate Press setting the matter for public comment and City Council consideration for May 26, 2014; and

**WHEREAS**, on June 24, 2014, the City did hold a duly noticed public hearing and received final public comment on the Plan;




**SECTION 2.** The City Clerk shall certify to the adoption of this Resolution, which shall be effective upon its adoption.




